2. Wrong entry of Post and Subject Code of an employee.


Discrepancy, if any, should be reported in the prescribed format (in MS-Excel only):-

Requests of completion of incomplete transfer applications submitted by employees, change of request of transfer or modification of place of choice stations/KVs etc do not constitute any discrepancy or technical errors, therefore, such requests shall not be entertained by the KVS and should not be forwarded by the Principal/Controlling Officer to this office. It has been observed that employees who have not completed one year at present place of posting as on 30.06.2018 have claimed the TC/DC and even applied for request transfer also. In terms of para 9 of Transfer guidelines, such employees are not eligible for request transfer.

It should be brought in the notice of all employees of KVS that any discrepancy reported/communicated after last date shall not be entertained by the KVS.
