The MACPS envisages merely placement in the next higher grade pay in the hierarchy of the recommended revised pay bands and grade pay as given in section I , part –A of the first schedule of the CCS(Revised Pay) Rules, 2008.

Promotions earned /up gradations granted under the ACP scheme in the past to those grades which now carry the same grade pay due to merger of pay scales/upgradations of posts recommended by the Sixth pay Commission have been ignored for the purpose of granting upgradations under MACPS.

Financial upgradation under the MACPS shall be purely personal to the employee and shall have no relevance to his seniority position.

On the upgradation under the MACPS, pay of the employee shall be fixed under the provisions of Govt. of India orders as applicable from time to time.

The Official concerned can exercise an option within one month from the date of this order for fixation of pay either from the date of grant of MACPS or after getting increment on Ist July of the year whichever beneficial to him/her.
